TOWN OF BOW ISLAND PROVINCE OF ALBERTA BYLAW #2009-04

A Bylaw of the Town of Bow Island in the Province of Alberta to authorize a system of numbering houses and building sites within the Town.

WHEREAS Council of the Town of Bow Island has the authority under Section 7 (a) of the Municipal Government Act, being Chapter M-26, Revised Statutes of Alberta 2000 and amendment thereto, hereafter referred to as the Municipal Government Act, to enact bylaws respecting the safety, health and welfare of people and the protection of people and property.

AND WHEREAS the Council of the Town of Bow Island deems it necessary to establish a system of house number within the Town and to continue to maintain this system in order to provide fire protection and emergency services for the public of Bow Island in an expedient manner.

AND WHEREAS the Council of the Town of Bow Island deems it necessary to establish a system of house numbering in order for Town employees and Bylaw Officers to execute notices and utility closures on property owners.

NOW THEREFORE THE MUNICIPAL CORPORATION OF THE TOWN OF BOW ISLAND IN COUNCIL ASSEMBLED ENACTS AS FOLLOWS:

1. Short Title

This Bylaw may be call the "Numbering Bylaw".

2. Purpose

The purpose of this Bylaw is to establish and maintain a system of numbering houses and building sites within the Town of Bow Island.

3. Building Numbering

- 3.1 A number shall be allotted for each new building when a building permit is issued.
- 3.2 Property owners shall be responsible for displaying the number of the building in a location which is visible from the sidewalk or roadway.
- 3.3 Number are to be visible and legible from the street and may be lit by an outside light.
- Number are not to be obstructed by trees, shrubs or any ornaments hanging from the house.

- 3.5 Size of numbers should not be less than four (4) inches in height and not blend in with the colour of the house.
- For the purpose of house number, numbers made of metal, plastic or wood are acceptable, as long as they comply with Section 3.5 of this Bylaw.

4. Penalties

- 4.1 A person who contravenes or fails to comply with any conditions and order or required directed to him/her, pursuant to this Bylaw is guilty of an offence as listed in Schedule "A" of this Bylaw.
- 4.2 All fees, charges and late payment penalties levied pursuant to this Bylaw are debt due and owing to the Town of Bow Island and may be collected as such.

This Bylaw shall come into effect upon third reading.
