For a number of years these vacancies often went unfilled for extended periods of time. During this meeting I heard once again that the detachment isn't getting a lot of calls reporting issues in Town. It would appear that a big part of the problem is that the number published for the detachment is the admin number which is usually only answered during the day. If you have a serious life threatening emergency or accident, call 911. If you have a less urgent complaint call **403-545-2100**. This number connects with an RCMP dispatcher who will have a member respond in an appropriate manner and timeframe. Concerned about streeet racing, suspicious individuals, withness vandalism or some other crime? Call **403-545-2100**. The members are more present and visible in our detachment area, which is huge, but we can all help by calling in.

I also just learned that the Hiebert Cabinets team is busy turning out their quality products in temporary quarters beside Jade Homes. While the company wrestles with the insurance company and makes plans for moving forward, their resilient staff is carrying on.

For a number of years Bow Island has contracted with Park Enterprises to provide Safety Coides Servies for Building, Electrical, Plumbing and Gas services within the Town. As of October 1st these permits will be administered by **The Inspections Group Ltd**. Any permits opened prior to October 1st will remain with Park Enterprises until the work is completed and the the permits are closed. The Town's contract with Park was expiring and due for some changes so Administration asked for quotes and proposals from several companies and chose The Inspections Group. Anyone requiring a permit will deal directley with The Inspections Group but you can get information on how to connect with them from the Town Office.
